### **COMMENTS ON AGENDA ITEMS**

- 109-18 Dr. Estrop inquired about the replacement stainless steel dump bodies. Service Director Moore explained the requested dump bodies will be put onto the three recently-approved cab and chasses. Accessories are bid out separately and will replace one 2001 and two 2004 models.
- 110-18 Dr. Estrop thanked the donors of personal flotation devices to the Fire Rescue Division. Assistant Fire Chief Smith stated that two members of the Box 27 Auxiliary made the donation. The Box 27 members provide assistance at fire scenes with air tank refills, water and coffee, and other helpful services.
- 111-18 Dr. Estrop asked Community Development Director Meadows to explain the 2018 Historical District Improvements Loan Program. Mrs. Meadows stated the program would provide up to \$10,000 as an inteterest-free loan for exterior improvements and lead-free interior improvements to income-eligible citizens living in the two designated historic districts, the South Fountain Preservation District and the East High Street Historic District.
- **79-18** Mr. Rue asked for the location of Section 2 of the 2018 Sidewalk, Curb and Gutter Program. City Manager Bodenmiller defined the area as U. S. Route 40 from North Limestone Street to the Lagonda Overpass in conjunction with an ODOT project.
- **118-18 and 119-18** Dr. Estrop asked for confirmation that the two street sweeper ordinances pertained to the lease agreement and the purchase of one new sweeper, and Finance Director Beckdahl agreed.
- Dr. Estrop also asked about required sweeping of city streets. Mr. Moore explained Ohio EPA requirements for every street to be swept during the year and the work is completed by a contracted company. City staff also sweeps thoroughfares with a city-owned sweeper.
- Mr. O'Neill asked for the life expectancy of new street sweepers. Mr. Moore stated the capital plan is to keep the hardware for seven years, but the equipment may be kept for up to ten years if possible.
- **8-16** Mrs. Chilton asked for information pertaining to the Community Gardens project. Mrs. Meadows stated the senior housing project is located at former site of Community Hospital.
- **120-18** Dr. Estrop inquired why the road salt ordinance is for emergency consideration. Mr. Moore stated that each year the ODOT purchasing contract has a very short time period to respond requiring emergency adoption.
- **121-18** Mr. O'Neill asked for details on the purchase of property at 231-235 North Shaffer Street. Mrs. Meadows explained the acquisition of the two subject lots along with other neighboring properties will be developed into new single-family housing units owned by Mental Health Services.
- 177-17 Dr. Estrop asked about the changes to the contract for the Miscellaneous Sanitary Sewer Lining Phase 1 Project. City Engineer Shanayda explained that the sewer line size was different that the original contract specifications which required a pricing change.
- 219-16 Mr. O'Neill asked if the Bird Road traffic signal is located within the city limits, and Mr. Shanayda replied that it is within the corporation limits.
- 122-18 Mr. Rue asked why the 2018 PI Paving Project requires emergency consideration. Mr. Bodenmiller stated that after this project was bid out, emergency award of contract would allow for the project to begin more quickly. Mr. Bodenmiller reminded commissioners that this project is for neighborhood streets. Commissioners promised to spend \$2 million on these streets, and the bids came in at nearly \$1.5 million. An additional \$500,000 will be available this year for additional streets that were originally planned for next year.
- **267-14A** and **267-14B** Dr. Estrop asked for an explanation of the two ordinances pertaining to Bechtle Signals project. Mr. Shanayda explained that one ordinance is for the change order with the contractor completing the work and the other ordinance is for the ODOT funding agreement.
- 124-18 Mrs. Chilton asked for a description of a detox sauna that was donated to the Fire Division. Assistant Chief Smith explained that a detox sauna is used to sweat out toxins from the skin after exposure at a fire scene. The intent is for cancer prevention among firefighters who have multiple exposures to carcinogenic materials during their career.

#### **COMMENTS FROM COMMISSIONERS**

**25-18** Dr. Estrop presented a proclamation proclaiming Saturday, May 12, 2018, as National Association of Letter Carriers National Food Drive Day. The proclamation was accepted by Ken Stickland, Acting Postmaster, and

officers of the National Association of Letter Carriers Branch 45: Melissa Blackburn, Treasurer; Stacy Strayer, Vice President; Brian DeWell, Branch President; and Brian Gourilias, Secretary. Mr. Strickland stated that the 2018 campaign is the 26<sup>th</sup> year of collecting food for local food pantries.

- **25-18** Mr. Rue presented a proclamation proclaiming May 14 through 20, 2018, as Salvation Army Week. Accepting the proclamation from the local Salvation Army was Major Bob Watson, Lieutenant Anita Albert-Watson, Development Director Ryan Ray, and members of the Advisory Board. Lieutenant Albert-Watson thanked the commissioners for recognizing 133 years of service in Springfield.
- **25-18** Mr. Rue spoke on a recent fire at his business, and thanked the city firefighters for their fast response to save the building from major destruction.

### **COMMENTS FROM THE AUDIENCE**

- **25-18** Mr. David Sanford, 528 South Yellow Springs Street, spoke on property surveys and need for permits when erecting fences as they are often placed on the neighboring owner's property.
- **25-18** Mr. Carl Ruby, Senior Pastor of Central Christian Church, spoke his concerns of the sexual-oriented business located downtown. He also stated that he leads a support group for those addicted to pornographic material. He submitted a letter to commissioners from another citizen who was unable to attend.
- Mr. Copeland commented that the Law Director is reviewing the situation for what the city can legally do about it.
- Dr. Estrop suggested that concerned citizens contact the property owner, Art Wilson, instead of the operator of the business.
- **25-18** Amy Wilman, Executive Director of Safe Harbor, spoke on research related to women who have been victims of sex trafficking. She indicated that outreach and education would work better than protests and condemnation.
- Mr. Copeland thanked Ms. Wilman for the work done on behalf of the victims and stated that the city is looking at its legal options related to the business.
